Members have attended Democracy NC meetings and trained to present voter education workshops on the Constitutional Amendments and what is on the ballot. Sorors Meta and Amanda will be scheduling this workshop with chapter members and other organizations before the November 6th election. Social Action Committee had its first retreat 7/28/18 to formulate activities and we developed our sorority year calendar. Activities will include Civics 101, voter education programs, and Domestic Minor Sex Trafficking activities with local recreation centers and continue to partner with Child Advocacy Center and voter registration activities. You will see on the chapter calendar monthly meetings of all of the Fayetteville governmental agencies. This is to encourage Sorors to be engaged and attend civic meetings and keep our chapter informed on local issues. Those Sorors who live in Hope Mills, Linden, and other municipalities in FAC's service area, can submit to Soror Figgins local government agencies' meeting dates and times that are important to them and for chapter members to attend. On 8/5/18 members attended a Community Bash: Families Belong Together Public Forum, sponsored by the Community Awareness Alliance at College Lakes Park and Rec. There was a Voter Registration activity on 8/23/18 at the Community Homeless Stand Dow presented by Fayetteville Veteran Affairs Medical Center, City of Fayetteville and Volunteers of America. Five (5) voter registration forms were submitted to Cumberland County Board of Elections, one absentee form provided, and two (2) were provided that will be mailed to the BOE by the registrant.
