Protocol: Soror Miller-Bernard

Soror Vera Bell read the following report:

Committee chose and Madam President approved "Pearls of Protocol" to be presented at the April chapter meeting: attire for Mock National Convention that will be held on Saturday, April 27, 2019, is all white - no pants, no hats. You may accent with pearls, violets and/or a white wrap for warmth, if desired. Reference--Protocol and Traditions Manual, revised 2011, Proper Attire for National Convention, Regional Conferences, Meetings, and Ritualistic Ceremonies-pgs. 19-21.

The committee strongly recommends, for safety concerns, that sorors enter the back door for chapter meeting and keep the front door locked (from the outside). If a soror invites another soror to chapter meeting, she notifies Madam President at least a week prior to meeting (if possible), giving her the name of visiting soror and membership number. If the visiting soror doesn't know her membership number, this will give her time to contact Grand Chapter for assistance. Visiting sorors will need to sit in a designated area and/or wear a visiting soror name tag. This will assure that those sorors will not receive chapter financial reports. If a Sergeant-at-Arms is absent from the chapter meeting, Madam President should appoint a temporary Sergeant —at-Arms. This will ensure doors are covered in addition to other duties.
